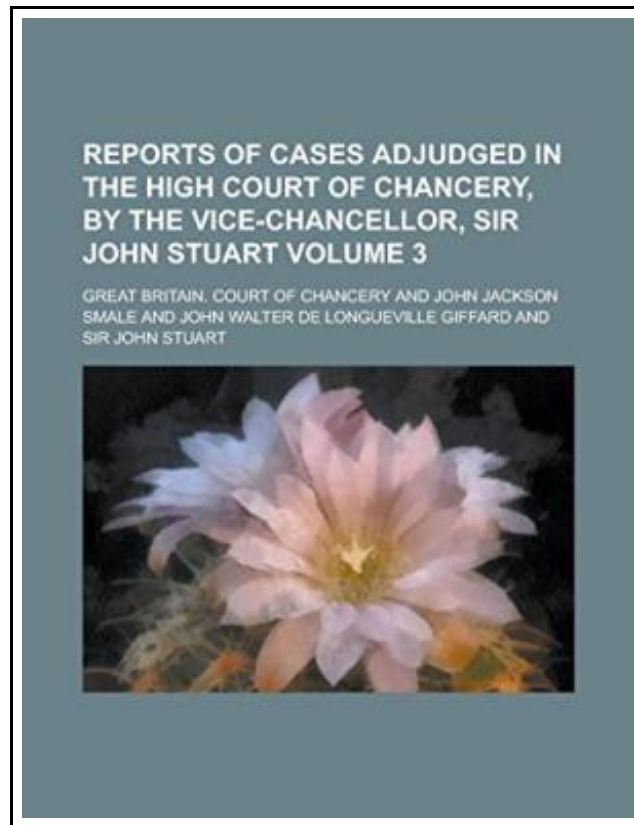

Excerpt: .80001., the testatrix had a clear general power of appointment by will, and in default of appointment it was in trust for such person or persons as at her decease would be entitled according to the Statute of Distributions, if she survived the testator and died intestate and unmarried. As to the other moiety of the 80001., and as to the 50001., the power of appointment was limited to persons of her blood and kindred. The will of Catherine Goodrich Shedden contains no reference to any power of appointment. It contains no gift of her personal estate otherwise than by naming executors. It contains no gift of the residue of her personal estate. On the contrary, it contains gifts of pecuniary legacies given in a general way, and also gifts of some specific articles to be given to the legatees whom she names. The language is ungrammatical, and the whole instrument is inartificially framed. If her other assets were sufficient to answer the legacies, there would be no pretence for construing this will as an execution of the general power of appointment. The question, therefore, whether the case can be brought within the operation of the 27th section of the new Wills Act is of great difficulty and importance. The general scope of that clause is to make general gifts operate as an execution of general powers of ap 1856. pointment. But the language of the Act requires that INTHOM there shall be, not...
